

Hambden Township Park Board  
Regular Meeting  
August 14, 2017

Hambden Park Board met in regular session on August 14, 2017 at 6:00 p.m. in Hambden Township Hall. The following members were present: Mike Romans, Joyce Edelinsky, Barry Bishop and Dan O'Reilly. Absent were Eric Germovsek and Linda Petkosek.

**EAGLE SCOUT PROJECT**

No update at this time on the Eagle Scout Project.

**MINUTES**

Motion to accept the July 17, 2017 minutes with the following corrections: under "B" cost of the info box is \$480.00 instead of \$395.00 and under D. We have 11 picnic tables instead of 10 by Barry Bishop, second by Dan O'Reilly. Motion carried.

**OLD BUSINESS**

**A. Bleachers** – the new bleachers are complete and installed. We are still waiting to hear from the trustees and Claridon Township regarding the old bleachers.

**B. Trail map/trailhead info box** – Barry presented the final draft of the trail head map. Joyce met with Jodi and discussed waterproof maps with UV protection. Mike will follow up with Chuck Arndt to see the status of the info box.

**C. Review of Park Signs/trash receptacle signs** –Mike obtained 3 quotes for 2 of each of the following signs: (1)Park Closes at Dusk; (2)No horseback riding and (3)All dogs must be on a leash. First quote from Allways Flasher is \$162.00 plus shipping or pickup as they are local; Second quote Judco \$116.00.00 with Judco representative delivering for free; and Third quote Osburn Associates \$89.00 plus shipping from Logan, OH 43138. After discussion the board felt that the \$27.00 difference between Osburn and Judco would be a wash as shipping would most likely be \$27.00 or more which would make Judco a lower overall cost. Also if the rep from Judco delivered we would be able to inspect the signs. Motion by Mike Romans, second by Barry Bishop to accept the quote from Judco for \$116.00 with the rep delivery. Motion carried, all yes.

**D. 2017 Maintenance Projects Update – Seal concrete tables:** Dan talked with the sealer rep from Iron Man and was told that if the tables were sealed in the past the sealer would only last 4-5 years and would be gone after that. No cleaner would be necessary in that case. We discussed power washing before sealing the tops only. The sealer can be applied with a sprayer. The cost is \$389.00 for 5 gallons. Dan will see if he can get 2 more quotes and calculate how much is needed for eleven 30" by 98" tops.

**Stain pavilions** is complete. **ADA striping** is not done yet on the East side.

**E. Community Day Picnic** – the picnic went well.

**NEW BUSINESS**

**A. Baseball Travel Team** – Hambden Havoc. Mike met with Coach Joe Gigliotti and had him sign a Mutual Hold Harmless agreement. Joe also provided insurance and a fall schedule for field 3 usage. A second team is also inquiring about the field use. Mike will follow up with the second coach.

**B. Park Portable Restrooms** – Keith send a letter to ASAP stating they must be there during working hours 7AM to 3:30PM for the Road Dept. to unlock the gate. Mike talked to the new driver who told him the schedule for cleaning will be Monday and Thursday. Joyce received a call from Cheryl Clemson representing a new company CLN in Burton. They were told that we have a contract for this year but we will want a quote for next year.

**C. Tree Removal** – Joyce talked to Dave about the numerous dead and dying trees in the park common area. Dave thought that the Road Dept. could remove them. We will have to obtain quotes for stump removal. Joyce and Barry will work on the next spring tree planting.

The next regular meeting will be held on September 18, 2017 at 6:00 p.m. There being no further business to come before the board at this time motion by Barry Bishop, second by Mike Romans to adjourn at 6:53 p.m.
